

Mater Christi Attendance Strategy

Stage 1 - Expect	 ALL families to be sent a fermly affendance letter and affendance certificate. 	
Stage 2 – Monitor When attendance falls below 91%	 Formal letter sent home with attendance certificate informing parent/carer of current attendance percentage and next steps. 	
Stage 3-Listen and Understand When attendance falls below 80%	 Formal letter sent home with Individual Attendance Plan for parents/carers to agree and sign. 	

Support When attendance falls below 70%

Stage 4-Facilitate

- Formal letter from the Multi Academy Trust sent home inviting parents/carers into school for attendance meeting with headteacher.
- Early Help Assessment advised and referral made to Child and Family Wellbeing Service.

Stage 5-Formalise Support/Enforce Possible Penalty Notice or Prosecution If no improvement or engagement after Stage 4, school will refer to the Local Authority for possible legal interventions.

*The trigger for legal intervention is 10 sessions (the equivalent of 5 days) of unauthorised absence in a term, or 14 sessions (the equivalent of 7 days) of unauthorised absence across 2 consecutive terms (LCC 2024)

Legal interventions for school non-attendance include:

Penalty notice

Parents may be issued with a penalty notice as an alternative to prosecution. If they pay the fine, they can discharge liability for the offence of failing to ensure their child's regular attendance at school.

Prosecution

Parents may be prosecuted in the Magistrates' Court and receive a fine, a community order or be imprisoned.

Parenting Order

If a parent is convicted for failing to ensure their child's regular attendance at school, a Parenting Order may also be applied for. This may require them to attend parenting classes and may specify other relevant directions for the parent.

Education Supervision Order

An application for an Education Supervision Order may be made, which appoints a local authority supervisor for the family and requires the parent and/or child to follow their directions.

^{*} For cases meeting the 14-session trigger, due to constraints in court evidential periods, absences should be aggregated across two consecutive terms – e.g. Autumn half-term 2 and Spring half-term 1.

Every Day Counts

At St. Joseph's Catholic Primary School, we know that good attendance is the key to successful schooling and we believe our pupils can be the very best!

Although we aim for 100% attendance, each year we set an attendance target and this is used to compare us to other schools locally and nationally. Our current target is 96%.

Attending school every day will help give your child the **best possible start in life**.

Going to school every day means learning new skills and becoming:

• A READER, WRITER, MATHEMATICIAN, SCIENTIST, GEOGRAPHER, HISTORIAN, ARTIST, MECHANIC, TAILOR, ELECTRICIAN, ENGINEER, BUILDER and CHEF!

It also means:

- making friends
- learning to hold a conversation
- having fun!

You can help your child by getting them to school every day.

Good attendance helps your child to develop their confidence and to make and keep lasting friendships.

Your child's attendance is very important; good attendance habits established in the primary school years can positively affect their entire school life.

Did you know?...

If you take your child on a **2 week holiday** in term time, attendance for the year **immediately drops to 95%** 90% attendance is equivalent to missing 100 hour-long lessons

90% attendance is equivalent to a full month off school in a year! 90% attendance means 1/2 a days absence each week; 4 weeks over the year and half a years absence over 5 years!!

Did you know?...

You can be fined up to £2,500 or given a 3 months prison sentence if your child misses too much school. Around 80 million days are lost to absence each year!

Research shows

that pupils who attend school regularly are more likely to do well in the future sound a day.

children in EYFS and KS1 learn a sound a day.
Missing just 1 day means they fall behind.

Holidays

PLEASE THINK CAREFULLY BEFORE TAKING YOUR CHILD OUT OF SCHOOL DURING TERM TIME

By law, you must ask for permission for your child to miss school.

Leave in term time will only be agreed where the Headteacher feels there are exceptional circumstances. Also, it is possible that leave will not be agreed when attendance already includes unauthorised absence and/or attendance is already causing concern.

You can request 'leave in term time' for your child using a request form available from the School Office.

Parents/Carers who take a child of compulsory school age on holiday without permission from the school may be issued with a **penalty notice**.

TO HELP YOUR CHILD DO WELL IN SCHOOL, YOU SHOULD...

- Arrange family holidays to coincide with school holidays
- Never take your child out of school when there are important examinations or tests (SATs and end of term Assessments)
- Be aware of the potential impact on your child's education. They will need to catch-up!
- Avoid taking your child out of school when they are just starting.
 This is very important as your child needs to settle into their new environment as quickly as possible.





Holidays

There are 190 statutory school days in 1 year. That means there are 175 days (weekends and school holidays) available to use for holidays!

There is **no** automatic entitlement in law to time off in school time to go on holiday

The Headteacher **cannot** authorise any leave in term time unless there are exceptional circumstances.

Any period taken without agreement of the school, or in excess of that agreed, will be classed as unauthorised and may attract a **Penalty Notice**.

A 2 week holiday in school time means your child has approximately 50 hours of missed learning to catch up on!

Policy and Procedures

- Ensuring your child's regular attendance at school is your legal responsibility.
- Pupil attendance is closely monitored. The MAT, Local Authority, Headteacher and Attendance Lead will check pupil attendance percentages regularly to see if action is required.
- First response calls and Class Dojo messages will be made daily if a child does not attend school.
- Classes are encouraged to compete for the best weekly attendance and the winning class feature on the Attendance Rocket and are awarded the weekly attendance trophy to proudly display in their classroom. The class with the most wins in a half term receive a prize of their choice.
- If attendance drops below 91%, pupils are identified as 'Persistent Absentees'. Our MAT/School Attendance Protocol will be initiated. (see back of booklet)
- A pupil becomes a 'persistent absentee' when they miss 9% or more schooling across the school year for whatever reason.
- All persistent absent cases are also automatically made known to the MAT and Local Authority Attendance Team. Persistent absentee cases will be closely monitored to see if further action is required.
- Attendance Officers can use sanctions such as Penalty Notices or Prosecutions in the Magistrates Court.
- Taking leave in term time will affect your child's schooling as much as any other absence and we expect parents/carers to help us by not taking children away in school time. THANK YOU

Absences

Every half-day absence from schoolhas to be classified by the school as either **AUTHORISED** or **UNAUTHORISED**. This is why information about the cause of any absence is always required and proof may be requested (medical prescription, appointment card etc.)

Authorised Absences

Authorised absences are mornings or afternoons away from school for a valid reason like illness, medical/dental appointments which unavoidably fall in school time, emergencies or other unavoidable cause.

Unauthorised Absences

Unauthorised absences are those which the school does not consider reasonable and for which no 'leave' has been given. This type of absence can lead to the Local Authority using sanctions and/or legal proceedings.



How you can help

- Aim for 10 hours sleep a night for your child. This will make the following day at school easier for them to cope with
- Make sure your child eats breakfast, it helps them to stay alert at school.
- Help your child develop routines.
- Encourage your child to get their school things ready the night before.
- Develop a nght time routine that involves checking their reading, homework and bed.
- Try and make sure that any medical/dental appointments are made for after school.
- Never take holidays in term time.
- If you know your child will be absent from school, notify the School Office before the day of absence.
- If your child is ill, ring the School Office as soon as possible on the first day of absence. (please do not send messages via Class Dojo)







Punctuality

Poor punctuality or leaving before the end of the school day is **not acceptable**.

School data shows a **link between poor attendance and under achievement**.

Missing just 10 minutes of a school day is the same as missing 2 weeks over the year!



Pupils who arrive late and/or leave early also **disrupt lessons**, which can be embarrassing for the child and can in turn, encourage absence. It is also extremely disruptive to the teacher and the rest of the class.

School starts at 8.55am and ends at 3.10pm (KS1) 3.15pm (KS2)

Doors open at 8.45am

Playgrounds are supervised from 8.30am and free toast is available


